

ARTICLES OF INCORPORATION

OF

JEFFERSON DAVIS HISPANIC ALUMNI ASSOCIATION

We, the undersigned natural persons, who are of the age of eighteen (18) years or more, acting as incorporators of a corporation under the Texas Non-Profit Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I.

NAME

The name of the corporation is JEFFERSON DAVIS HISPANIC ALUMNI ASSOCIATION.

ARTICLE II.

NONPROFIT CORPORATION

The corporation is a nonprofit corporation.

ARTICLE III.

DURATION

The period of its duration is of perpetual duration.

ARTICLE IV.

PURPOSES

The purpose for which the corporation is organized is to provide college or university scholarships for hispanic members of the graduating class of JEFFERSON DAVIS SENIOR HIGH SCHOOL, Houston Harris County, Texas.

ARTICLE V.

INITIAL REGISTERED OFFICE AND AGENT
